**PROCEEDINGS:**

Based on representation from Distribution circles, the Executive Engineers & Superintending Engineers of Electricity Distribution Circles were delegated with separate powers for execution of various centrally aided scheme works viz, DDUGJY & IPDS vide BP cited in ref (2).

The IPDS & DDUGJY requirements, stipulates that tenders of value more than Rs.2.00 lakhs have to proceed only through online mode.

In the said B.P while delegating Powers to Superintending Engineers /EDCs, the limit has been specified as "Not Exceeding Rs.2,00,000/- with 5% excess over technically sanctioned estimate.( **excluding** applicable GST,EPF & ESI ) In such an event the value of tender will be more than Rs.2.00 lakhs (inclusive of ESI, EPF & GST) which constrains Superintending Engineers /EDCs to process the tender through online procedures.

In order to comply with such a direction, it was specified that Superintending Engineer/EDC's shall process the tender proposals through E-tender as per scheme requirements.

Now representations have been received from Chief Engineer/ RAPDRP, requesting to amend the said delegation of Powers to Superintending Engineers /EDCs as "Not Exceeding Rs.2,00,000/- with 5% excess over technically sanctioned estimate.( **including** applicable GST,EPF & ESI ), so as to process the tenders through off line

procedures & expedite the works to ensure completion the work within the timeline specified as per scheme guidelines.

Now the Board after careful consideration has decided to revise the terms as "Not Exceeding Rs.2,00,000/- with 5% excess over technically sanctioned estimate.(**including** applicable GST,EPF & ESI) and **delete the terms** "to be processed through E-tender as per Scheme requirements" in the Table VII of Works contract Limited Tender.

Consequent to the amendment, the following tender powers under Table VII is produced as below:
