Sub:-Theft of energy by illegal tapping for festivals / public meetings / processions / public functions, etc. – Insisting organisers to obtain NOC from TNEB – Reg.

All the Chief Engineers/Distribution Region vide references cited were requested to instruct the field officials under their control to issue 'No Objection Certificate' after ensuring the safety norms and non-occurrence of theft of energy whenever the festival organisers approach the TANGEDCO for conducting religious functions such as Vinayagar Chadurthi.

Non-issuance of NOC by the TANGEDCO officials to the festival organisers of the religious functions and failure to prevent Theft of energy by the TANGEDCO officials lead to filing of Public Interest Litigations by various activists.

In this regard, it is stated that the format of NOC to be issued by the Assistant Executive Engineer/O&M to the festival organisers was already communicated vide references cited above. Whereas, it is noticed that most of the

officials do not issue NOC to the festival organisers and this inaction may weigh down the image of TANGEDCO before the Hon'ble Court.

Therefore, all the Chief Engineers/Distribution Region are requested to instruct the field officials under their control to issue NOC officials after ensuring the safety norms and non-occurrence of theft of energy whenever the festival organisers approach the TANGEDCO.

Further, whenever TANGEDCO's supply is sought, temporary supply under LT category shall be given as per the rule in force. Apart from these, possible steps may also be taken to curb theft of electricity during the on-coming Vinayagar Chadurthi festival celebrations in the public places.

The Superintending Engineer/Enforcement is also requested to deploy the necessary enforcement teams to detect theft of electricity during festival season.
