Sub: TANGEDCO – Non-Tariff related Miscellaneous Charges Order issued by Hon'ble TNERC – With effect from 05.10.2019 - communication of Rates – Reg.

Ref: 1. M.P.No.7 of 2018 Order dated 03.10.2019.
2. CMD's approval in CFC/RC's Note dated 05.10.2019.

In the reference (1) cited the Hon'ble TNERC has issued orders regarding **Non-Tariff related Miscellaneous Charges with effect from 05.10.2019.**

II) The above order covers the rates with respect to the following Miscellaneous Charges, a copy of which is enclosed:

- 1) Service Connection Charges.
- 2) Meter Rent
- 3) Changing/Shifting of Meter Board/LTCT Box/HT Box due to damage or for accommodating additional safety features like ELCB etc.
- 4) Changing of Meter at the request of the consumer without any dispute in accuracy of the meter.
- 5) Installation Testing.
- 6) Replacement of damaged/burnt meter.
- 7) Inspection and Testing of meter when dispute arises in the accuracy (Challenge Test).
- 8) Periodical Inspection.
- 9) Meter Caution Deposit.
- 10) Temporary disconnection at the request of the consumer.
- 11) Reconnection Charges – LT.
- 12) Reconnection Charges – LT CT & HT.
- 13) Charges for dishonoured cheque – Service Charge.
- 14) Name Transfer of Service and name change for wind mill & solar generation services.
- 15) Registration cum Processing Charges.
- 16) Replacement of Consumer Meter Card.
- 17) Development Charges – LT & LTCT (Overhead).
- 18) Development Charges – HT (Overhead).

- 19) Development Charges – LT & LTCT (Cable).
- 20) Development Charges – HT (Cable).
- 21) Earnest Money Deposit.
- 22) Security Deposit.
- 23) Furnishing Certified Copies to Consumers.

III) Hence as per the reference (2) cited, the Superintending Engineers/ Distribution EDCs are requested to arrange to communicate the above rates to the officials concerned in their jurisdiction and to arrange to implement the same from 05.10.2019 onwards. The Superintending Engineers are also requested to arrange to display the above rates prominently in all the Circle/Division/Sub-Division/Section offices so that the consumers are well informed.
