Sub: TANTRANSCO – Employer contribution towards EPF and ESI – Not to reimburse it as extra over and above the contract value – Instructions issued - Reg.



In TANTRANSCO, tenders are floated for execution of works contract & service contract wherein the bidders are insisted to comply the relevant provisions stipulated in EPF & MP (Miscellaneous Provision) Act and ESI Act. Further, a condition is also stipulated in the tender specification that such bidders should have separate EPF main code number and separate ESI main code number.

Once the bidders have separate code number, the bidders are considered as independent employer. TANTRANSCO (Principal employer) could not be held liable for any lapses found in remittance of employer contribution towards EPF & ESI made by the contractor in the contracts entered by TANTRANSCO.

Considering the above, approval has been accorded for not to include employer contribution towards EPF & ESI in the estimates being prepared for execution of works, even for contracts involved in supply of man power and also not to reimburse the employer contribution towards EPF & ESI over & above the accepted value of works in all the contracts. However, it shall be ensured that the EPF & ESI have been remitted to the concerned authorities by obtaining a declaration from the contractor in the format enclosed while passing each and every bill under the contract.
