Tariff 1D – Order issued by Hon'ble TNERC – Instruction issued - Reg.

In the reference (1) cited above, Hon'ble TNERC has issued an order on reduction of tariff on common facilities in Multi-tenements by creating a new category under LT Tariff 1E for common facilities in Multi-tenements/Residential flats of small apartments without lift facility (3 & less than 3 floors with 10 & less than 10 dwelling units) vide Order No 9 of 2023 dated 31.10.2023 with effect from 01.11.2023.

1.1) The Tariff rates approved by the Hon'ble Commission along with subsidy by GOTN and charges payable by consumer for the new category LT Tariff 1E is as follows:

2.0) In this connection, the Superintending Engineer/EDCs requested to communicate the officials/staff concerned about the order issued by Hon'ble TNERC, in respect of reduction of tariff creation of a new tariff category LT Tariff 1E and make necessary arrangements to categorise the LT Tariff 1E from the existing ID Services. The provision for change of tariff from ID to IE has been provided to the Section officer. The section officer, after physical inspection, has to change the tariff from existing LT Tariff ID to LT Tariff IE wherever the following conditions are satisfied:

Details to be entered based on service's physical inspection

- a) Lift: Yes/No If Yes → No of Lifts _____
b) No. Of Floors: _____ (Including Ground Floor excluding Stilt Floor)
c) No. of Dwelling Units: _____

Only when all of the above conditions are satisfied i.e., [a) Lift: **No**, b) 3 & less than 3 floors, c) 10 & less than 10 dwelling units] the process of tariff change will be enabled.

3.0) Further an additional provision enabled in TANGEDCO Website for consumers, wherein consumer can request for tariff conversion from 1D to 1E by entering details against following 3 conditions [i.e., a) Lift: **Yes/No**, b) 3 & less than 3 floors: **Yes/No**, c) 10 & less than 10 dwelling units: **Yes/No**]. On satisfying all 3 conditions, a report will be generated in the AE/AEE user and the AE/AEE inturn, can carry out inspection for this service to save time and the existing tariff may be converted from 1D to 1E if all the above conditions are satisfied based on physical inspections.
