Sub: TANGEDCO – Shifting of Electrical Utilities – (Service/ lines, structure & equipments at the request of consumer) - Preparation of estimates under Deposit Contribution Works (DCW) – Labour & Transport charges – Clarification requested on the applicability of Labour charges 20% on the reusable items for materials and DT – Instruction Issued - Regarding.

The Chief Engineer/ Distribution/ Coimbatore and Erode region have sought for clarification whether the cost of Distribution Transformers and other Equipments should be taken into account for the calculation of Labour and Transport charges for re-erection of dismantled and reusable materials at new site (for loading from old site, unloading at new site and erection at new location) @ 20% of present value based on the audit paras raised by Board Audit (BOAB).

After careful consideration of the above request, the following instructions are issued regarding Labour & Transport charges for shifting works in DCW estimates:

Labour and Transport, i.e. 10% loading, unloading, transport charges and 10% erection charges totally 20% of the present value of the dismantled and reusable material for the cost of materials like AB switch, HG Fuse, LT fuse etc. for DCW works as per regulation 6(1)(ii) & (v) of TNE Supply Code may be collected

Labour and Transport, for equipments such as DT, Power Transformer, RMU etc., the labour rates approved by the concerned Electricity Distribution Circle may be collected.

Further it is instructed that for reusable materials/ equipments dismantled at the old site which are in good condition and reusable may be utilized in the new site/ anywhere else needed. However, the sanctioning authorities should not permit to reuse the materials dismantled in large scheme works such as shifting due to road widening at the request of NHAI, Highways, CMRL, where the dismantling and re-erection of electrical utilities could not be taken up simultaneously.

All field officers are instructed to adhere to the above instructions scrupulously.
